

APPLICATION FOR WATER SERVICE

Application is hereby made to the DCWWA for water service to my property. If this application is approved, I/we agree, at my/our own expense to:

- a) Do all excavating and lay service pipe at least five (5) feet below the final graded surface, and have the service pipe installation inspected by the DCWWA prior to backfilling.
b) Assume all liability and obtain all permits to open highway.
c) Assume responsibility for maintenance and repair of all service lines not originally furnished and installed by the DCWWA.
d) Restrict service to original building supplied with service under this permit unless written permission is obtained from the DCWWA to amend the service.
e) Provide for proper placement of the water meter with valves at both sides of the meter and any other by-pass arrangement or hook-up, that may be deemed necessary by the DCWWA. Provide for the installation of a properly approved back flow prevention device as required by the DCWWA.
f) Notify the DCWWA when the building is ready for occupancy and furnish correct name and address of property owner for billing purposes.
g) Acknowledge that the property owner is responsible and billed for all water service charges that are incurred by the property and that all unpaid water charges, including any accrued late fees and penalties assessed pursuant to the "Dutchess County Water District Rules and Regulations" and "Water Rate Schedule", may be levied against the property on the annual real property tax bill. Upon written request from the property owner and at the discretion of the DCWWA, a duplicate bill can be sent directly to the property occupant.
h) Not allow the water to be turned on or off at the main or curb stop except by the DCWWA or without special permission obtained from the DCWWA.
i) Accept service by the DCWWA in accordance with its rules and regulations as are now in force or shall become effective during the period of this contract.
j) Accept this application, when approved by the DCWWA, as a contract to continue in force until either party shall terminate it by thirty (30) calendar days written notice to the other. Such notice shall be made to the DCWWA at their official place of business. Notice made to the property owner shall be to the owner's last known address on file with the DCWWA.
k) When required by the DCWWA, make an escrow payment in the amount of \$500 payable to the DCWWA. Such escrow payment shall be used by the DCWWA to cover the costs of plan review, field inspections and other engineering costs as deemed necessary and proper by the DCWWA. Any unused funds shall be returned within 90 days after all necessary approvals have been executed. (Escrow generally not applicable for an individual residential water service connection.)
